THE UNDERSIGNED ACCEPTS AND ASSUMES ANY AND ALL RISKS IN USING THE EQUIPMENT AND THE CLUB FACILITIES. THE UNDERSIGNED AGREES TO RELEASE, INDEMNIFY, HOLD HARMLESS AND DEFEND THE CLUB, AND ANY OF ITS EMPLOYEES,

DIRECTORS, OFFICERS, AGENTS, AND VOLUNTEERS (AND THEIR HEIRS, EXECUTORS, TRUSTEES, AND BENEFICIARIES) FROM ANY AND ALL FAULT, LIABILITIES, COSTS (INCLUDING COST OF ANY SETTLEMENT OR JUDGMENT, COSTS OF COURT, AND ATTORNEYS FEES}, EXPENSES, CLAIMS, DEMANDS, AND LAWSUITS ARISING OUT OF, RELATED TO, OR CONNECTED WITH THE ACTIONS OR OMISSIONS OF THE UNDERSIGNED, OR OF THE UNDERSIGNED'S LICENSEES, GUESTS OR INVITEES OCCURRING AS A RESULT OF THE USE THE EQUIPMENT, AND INCLUDING ANY NEGLIGENCE ON THE PART OF THE CLUB, ANY MEMBER, EMPLOYEE, VOLUNTEER, OR AGENT OF THE CLUB OR ANY OTHER PERSON PRESENT AT OR PARTICIPATING IN CLUB ACTIVITIES.
