The Undersigned acknowledges, understands and assumes the inherent hazards and risks involved in shooting activities, both known and unanticipated, which could result in damage or destruction of personal property and physical or emotional injury and death of the Undersigned or other persons. THE UNDERSIGNED ACCEPTS AND ASSUMES ANY AND ALL RISKS IN USING THE EQUIPMENT AND THE CLUB FACILITIES. THE UNDERSIGNED AGREES TO RELEASE, INDEMNIFY, HOLD HARMLESS AND DEFEND THE CLUB, AND ANY OF ITS EMPLOYEES,

DIRECTORS, OFFICERS, AGENTS, AND VOLUNTEERS (AND THEIR HEIRS, EXECUTORS, TRUSTEES, AND BENEFICIARIES) FROM ANY AND ALL FAULT, LIABILITIES, COSTS (INCLUDING COST OF ANY SETTLEMENT OR JUDGMENT, COSTS OF COURT, AND ATTORNEYS FEES), EXPENSES, CLAIMS, DEMANDS, AND LAWSUITS ARISING OUT OF, RELATED TO, OR CONNECTED WITH THE ACTIONS OR OMISSIONS OF THE UNDERSIGNED, OR OF THE UNDERSIGNED'S LICENSEES, GUESTS OR INVITEES OCCURRING AS A RESULT OF THE USE THE EQUIPMENT, AND INCLUDING ANY NEGLIGENCE ON THE PART OF THE CLUB, ANY MEMBER, EMPLOYEE, VOLUNTEER, OR AGENT OF THE CLUB OR ANY OTHER PERSON PRESENT AT OR PARTICIPATING IN CLUB ACTIVITIES.

Membership Dues

Yearly dues along with a renewal application are submitted no later than January of the new year. For new members that join the club in the 1st quarter of the year (January 1 - March 31) dues will consist of the full amount.

For new members that join the club during the 2nd and 3rd quarter of the year (April 1 - September 30), dues will be prorated for the remainder of the year.

For new members that join in the 4th quarter of the year (after September 30) dues will include the following year's fee.

Prorated dues are determined by the membership fee divided by 12 to get the price per month. There is a \$30 fee for each new application
