THE UNDERSIGNED AGREES TO RELEASE, INDEMNIFY, HOLD HARMLESS AND DEFEND THE CLUB, AND ANY OF ITS EMPLOYEES,

Membership Dues

Yearly dues along with a renewal application are submitted no later than January of the new year. For new members that join the club in the 1st quarter of the year (January 1 - March 31) dues will consist of the full amount.

For new members that join the club during the 2nd and 3rd quarter of the year (April 1 - September 30), dues will be prorated for the remainder of the year.

For new members that join in the 4th quarter of the year (after September 30) dues will include the following year's fee.
